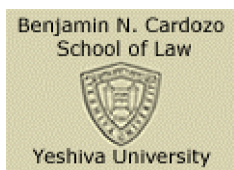

AIMS AND OBJECTIVES

- This course intends to present the main Alternative Dispute Resolution systems.
- The teaching methods will imply active participation of the students and will use video, internet, role playing and other teaching skills.
- During the course there will be a Transatlantic on line dispute resolution. Teams of our University will try to solve an international commercial conflict discussing by mail with north American, Italian and French teams.
- The course will have a recognition of 4,5 ECTS credits with **compulsory registration** and acceptance of the academic and administrative conditions of the course (compulsory attendance to the classes, active participation in the activities and preparation of materials that will be given to the registered students).
