LLM in US Legal Studies



University of California Hastings College of the Law is a public, coeducational, full-time law school in downtown San Francisco. It is one of the top-rated law schools in the United States.

Hastings was founded in 1878 as the first law department of the University of California and is one of the most exciting and vibrant legal education Centres in the nation. The faculty is nationally renowned as both teachers and scholars.

About the LLM

LL.M. candidates are required to complete successfully at least 24 credit hours of classes, including a legal writing and research seminar and one first-year required course (contracts, torts, criminal law, property, or civil procedure). LL.M. candidates who choose to concentrate in one of the areas of specialization, must pass at least 12 credits in their chosen area.

The Director of the LL.M Program helps each LL.M student select courses that are tailored to his or her interests. An LL.M. candidate may select any course (except a clinic) with the consent of the LL.M Director and subject to any prerequisites determined by the instructor for the class. LL.M. candidates are required to receive a passing grade in classes in order to obtain course credit and receive the degree. LL.M. students are otherwise subject to all of the academic and related regulations promulgated by the College.

- All the students follow a ONE-YEAR LL.M. DEGREE IN UNITED STATES LEGAL STUDIES.

The students that decide to follow one concentration will receive an additional Diploma in one of the following areas

- INTERNATIONAL LAW AND HUMAN RIGHTS
- SCIENCE, TECHNOLOGY AND INTELLECTUAL PROPERTY
- INTERNATIONAL BUSINESS AND TRADE
- DISPUTE RESOLUTION AND LEGAL PROCESS
- TAXATION
- FAMILY LAW
